### Anti-slavery and human trafficking statement

#### 1: Opening statement from senior management

#### 3: Policies

We are dedicated to maintaining a fair and ethical workplace for our staff, Customers, contractors and suppliers.

As part of our commitment to combating modern slavery, we also have the following policies:

#### 4: Due diligence

We expect all of our Customers, contractors, suppliers and other business partners to adopt the same high standards we have to preventing modern slavery.



Our key suppliers are global technology companies, and we have ensured that our key suppliers have a modern slavery statement in place and are therefore aware and actively preventing modern slavery in their workplaces.

We ensure whistleblowers are protected through our whistleblowing policy and procedure and feel able to notify us of any concerns internally or from suppliers they come into contact with.

#### 5: Risk and compliance

Tavant Technologies Ltd regularly evaluates the nature and extent of its exposure to the risk of modern slavery occurring in its supply chain.

We recognise that we operate with suppliers who have a global complex operation and have identified a potential risk may be with those who supply goods or services to our suppliers. We therefore expect out suppliers to be adhering to their modern slavery statements.

We will not tolerate slavery and human trafficking within our supply chains. For example, if we find evidence of a failure to comply with modern slavery practices or the Suppliers own policies we will immediately seek to terminate our relationship with the relevant supplier.

#### 6: Training and Culture

We are dedicated to maintaining a fair and ethical workplace for all of our staff.

It is important to us that our colleagues are aware of the issues surrounding modern slavery and support the firms values. We therefore intend to include modern slavery within the staff handbook for all employees as well as ensure our procurement, audit, legal and HR departments, as well as senior leadership team will have undergone mandatory training by the end of 2021/2022 financial year.

#### 7: Further actions

We will continue to strengthen our approach to managing risk of modern day slavery within our business and supply chains and maintain our expectations of employees to treat people fairly, equally, lawfully and to raise concerns about the treatment of people.
